FIRST AMENDMENT TO AGREEMENT NO. 34277

THIS FIRST AMENDMENT TO AGREEMENT NO. 34277 is made and entered, in duplicate, as of August 18, 2016, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on April 19, 2016, by and between LISA WISE CONSULTING, INC., a California corporation ("Consultant"), with a place of business at 983 Osos Street, San Luis Obispo, California 93401, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with coastal zone consulting services and

WHEREAS, City and Consultant entered Agreement No. 34277 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, City and Consultant desire to correct the term;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the parties agree as follows:

1. Section 2 of the Agreement is hereby amended to read as follows:

"2. TERM. The term of this Agreement shall commence at midnight on January 1, 2016, and shall terminate at 11:59 p.m. on April 1, 2017, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The term may be extended for two (2) additional one-year periods, at the discretion of the City Manager."

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 34277 are ratified and confirmed and shall remain in full force and effect.
