

1 to add \$500,000 for a total not to exceed amount of \$3,280,000; and

2 WHEREAS, the Parties entered into a Ninth Amendment to the Agreement
3 to add \$75,673.75 for a total not to exceed amount of \$3,355,673.75; and

4 WHEREAS, the Parties desire to extend the term one (1) additional one-year
5 period and add \$900,000 to the Agreement;

6 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
7 conditions herein contained, the Parties agree as follows:

8 1. Section 1.A. of the Agreement is hereby amended to read as follows:

9 "A. Consultant shall furnish specialized services more particularly
10 described in Exhibit "A", attached to the Agreement and incorporated by this
11 reference, in accordance with the standards of the profession, and City shall pay for
12 these services in the manner described below, not to exceed Four Million Two
13 Hundred Fifty-Five Thousand Six Hundred Seventy Three Dollars and Seventy-Five
14 Cents (\$4,255,673.75), at the rates or charges shown in Exhibit "B"."

15 2. Section 2 of the Agreement is hereby amended to read as follows:

16 "2. TERM. The term of this Agreement shall commence at midnight on
17 February 1, 2016, and shall terminate at 11:59 p.m. on January 31, 2021, unless sooner
18 terminated as provided in this Agreement, or unless the services or the Project is
19 completed sooner."

20 3. Except as expressly modified herein, all of the terms and conditions
21 contained in Agreement No. 34228 are ratified and confirmed and shall remain in full force
22 and effect.






