## THIRD AMENDMENT TO CONTRACT NO. 29929

THIS THIRD AMENDMENT TO CONTRACT NO. 29929 is made and entered, in duplicate, as of October 30, 2008 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on October 10, 2006, by and between the FAIR HOUSING FOUNDATION, a California nonprofit corporation ("Organization"), with a place of business at 3605 Long Beach Boulevard, Suite 302, Long Beach, California 90807, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the parties entered Contract No. 29929 to address housing and community development needs and City, in its 2006-2010 Consolidate Plan under Title I of the Housing and Community Development Act of 1974, as amended, has identified specific needs in the areas of housing discrimination and impediments to fair housing choices; and

WHEREAS, the parties desire to extend the term of the Contract;

NOW, THEREFORE, in consideration of the mutual terms and conditions in the Contract and this Third Amendment, the parties agree as follows:

- 1. Section 2 of Contract No. 29929 is hereby amended in its entirety to read as follows:
- "2. The initial term of this Contract shall begin on October 1, 2006 and end on September 30, 2007. The first extended term of this Contract shall begin on October 1, 2007 and end on September 30, 2008. The second and last extended term of this Contract shall begin on October 1, 2008 and end on September 30, 2009. This Contract only governs services provided to City's residents and persons seeking housing in the City."
- Except as expressly amended in this Third Amendment, all terms and conditions in Contract No. 29929 are ratified and confirmed and shall remain in full force and effect.
