1 FIRST AMENDMENT TO AGREEMENT NO. 33387

3 THIS FIRST AMENDMENT is made and entered, in duplicate, as of  
4 November 1, 2014, pursuant to a minute order adopted by the City Council of the City of  
5 Long Beach at its meeting on January 21, 2014, by and between APOLLO  
6 PROFESSIONAL SOLUTIONS, a Massachusetts corporation, with a branch located at  
7 4010 Watson Plaza Dr., Suite 138, Lakewood, CA 90712 ("Consultant"), and the CITY  
8 OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, the City requires specialized services requiring unique skills to  
10 be performed on an as-needed basis in connection with professional and technical  
11 services for information technology projects and systems ("Project"); and

12 WHEREAS, now the parties desire to clarify the terms of Agreement No.  
13 33387;

14 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
15 conditions in this Agreement, the parties agree as follows:

16 1. Section 1.A. of Agreement No. 33387 is amended to read as follows:

17 "1.A. SCOPE OF WORK OR SERVICES.

18 A. Consultant shall furnish specialized services more particularly  
19 described in Exhibit "A", attached to this Agreement and incorporated by this  
20 reference, in accordance with the standards of the profession, and City shall pay  
21 for these services in the manner described below, in an annual amount not to  
22 exceed One Hundred-Fifty Thousand Dollars (\$150,000.00), at the rates or  
23 charges shown in Exhibit "A".

24 2. Except as expressly amended herein all of the terms, covenants, and  
25 conditions of Agreement No. 33387 as amended shall remain in full force and effect.
