3 RESOLUTION OF THE CITY COUNCIL OF THE CITY  
4 OF LONG BEACH URGING THE CALIFORNIA STATE  
5 LEGISLATURE TO ENACT ASSEMBLY BILL 2041  
6

7 WHEREAS, Harbor Departments of the Cities of Los Angeles and Long  
8 Beach predict that truck traffic to and from the ports of San Pedro Bay will more than  
9 double in the next 20 years from roughly 35,000 trucks to nearly 83,000 trucks per day;  
10 and

11 WHEREAS, trucks emit air contaminants and contribute to congestion on  
12 local freeways and streets; and

13 WHEREAS, most trucked cargo currently moves on local freeways and  
14 streets during daylight hours; and

15 WHEREAS, AB 2041 would establish a charge for cargo moving by truck  
16 on weekdays between 8:00 a.m. and 5:00 p.m.

17 NOW, THEREFORE, the City Council of the City of Long Beach resolves  
18 as follows:

19 Section 1. That the City Council supports AB 2041 in order to reduce the  
20 contribution of trucks to peak hour congestion.

21 Sec. 2. That the City Clerk is directed to transmit a copy of this resolution  
22 to the Governor, to the members of the California Legislature representing the Long  
23 Beach and Los Angeles areas, and any other officials, agencies, entities, and  
24 individuals as may be deemed appropriate.

25 Sec. 3. This resolution shall take effect immediately upon its adoption by  
26 the City Council, and the City Clerk shall certify to the vote adopting this resolution.


