### Subject: ABC License for Jason Chang Muk Kang, dba Seoulmate 4712 East 7<sup>th</sup> Street, Long Beach, CA

I am submitting the following conditions for your consideration for an original application for an On-Sale Beer and Wine license for a bona fide eating place.

- 1. Sales, service, and consumption of alcoholic beverages shall be permitted only between the hours of 10:00am until 10:00pm Sunday through Saturday.
- 2. The quarterly gross sales of alcoholic beverages shall not exceed 30% of the gross sales of food during the same period. The licensee shall at all times maintain records which reflect separately the gross sale of food and gross sales of alcoholic beverages of the licensed business. Said records shall be kept no less frequently than on a quarterly basis ad shall be made available on demand.
- 3. There shall be no exterior advertising or sign of any kind or type, including advertising directed to the exterior from within, excluding menus promoting or indicating the availability of alcoholic beverages.
- 4. No "happy hour" type of reduced price alcohol beverage promotion shall be allowed.
- 5. The sale of alcoholic beverages for consumption off the premises is strictly prohibited
- 6. The licensee shall prevent loitering or other activity in and near the premises that could be nuisance to adjacent uses and/or residential neighborhoods.
- 7. The seating shall consist of tables and/or booths. There shall be no designated sitting or standing bar area.
- 8. No live entertainment, dancing, or disc jockey shall be permitted outdoors or on the premises at any time.
- 9. The licensee shall ensure that shipping and/or receiving activities occur only between 8am and 10pm.
- 10. The licensee shall ensure that trash and other refuse is deposited in closed containers, outside and in the rear of the premises, and only between 8am and 10pm.

- 11. The licensee shall ensure that outside trash and refuse containers are serviced by sanitation companies only between 8am and 10pm.
- 12. The licensee shall ensure that alleys, streets, or other public areas are not used by employees and/or contractors of the licensee for equipment or utensil cleaning or other sanitary purposes.
