35182 THIS FOURTH AMENDMENT TO AGREEMENT NO. 35182 is made and entered, in duplicate, as of September 19, 2023, for reference purposes only, pursuant to minute orders adopted by the City Council of the City of Long Beach at its meetings on October 3, 2017, August 10, 2021, and September 12, 2023, by and between TRUEPOINT SOLUTIONS LLC, a California limited liability company ("Consultant"), with a place of business at 3262 Penryn Road, Suite 100-B, Loomis, California 95650, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35182 (the "Agreement") whereby Consultant agreed to provide as-needed professional and technical services related to Land Management/Business Permits ("Project"); and

WHEREAS, the Parties entered into a First Amendment to the Agreement to increase the contract in an amount not to exceed \$600,000 and extend the term to March 31, 2021; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to extend the term to March 31, 2022; and

WHEREAS, the Parties entered into a Third Amendment to extend the term to March 31, 2023; and

WHEREAS, the parties desire to add \$300,000, for a total contract amount not to exceed \$900,000, and extend the term for one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 1.A. of the Agreement is hereby amended to read as follows:
- "A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in

the manner described below, not to exceed Nine Hundred Thousand Dollars (\$900,000), at the rates or charges shown in Exhibit "B"."

- 2. Section 2 of the Agreement is hereby amended to read as follows:
- "2. <u>TERM.</u> The term of this Agreement shall commence at midnight on April 1, 2019, and shall terminate at 11:59 p.m. on March 31, 2024, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."
- 3. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 35182 are ratified and confirmed and shall remain in full force and effect.
