FIRST AMENDMENT TO WORKERS' COMPENSATION PHARMACY BENEFITS ADMINISTRATION AGREEMENT NO. 35140

THIS FIRST AMENDMENT TO WORKERS' COMPENSATION PHARMACY BENEFITS ADMINISTRATION AGREEMENT NO. 35140 is made and entered, in duplicate, as of December 9, 2020, for reference purposes only, by and between TMESYS LLC, ("Tmesys") a Florida limited liability company, as successor-in-interest to PHARMACEUTICAL TECHNOLOGIES, INC., D/B/A CASTIARX, a Nebraska corporation ("PTI"), and the City of Long Beach, a California municipal corporation ("City"). Tmesys and the City are collectively referred to as the "Parties".

WHEREAS, City and PTI entered into Agreement No. 35140 (the "Agreement"), effective January 1, 2019, for pharmacy benefits management (PBM) services; and

WHEREAS, PTI was purchased by OptumRx Holdings, LLC ("ORx Holdings") in December 2019 and transitioned the PBM services performed under the Agreement to the OptumRx platform and portal; and

WHEREAS, ORx Holdings is the parent company of several different entities that provide workers' compensation pharmacy benefit services, including Tmesys, LLC ("Tmesys"), also owned by OptumRx, Inc.; and

WHEREAS, in an effort to consolidate and streamline the provision of workers' compensation services under the OptumRx enterprise, all rights and obligations of PTI under the Agreement are being assigned to Tmesys and the Parties now desire to amend Agreement No. 35140 to replace the Optum contracting entity under the Agreement from PTI to Tmesys, to amend the Agreement to extend the term until December 31, 2021, and to substitute a new Network Pharmacy Reimbursement exhibit;

NOW, THEREFORE, in consideration of the mutual terms and conditions contained herein, the parties agree as follows:

1. All references in the Agreement to PTI or CastiaRx are replaced with

Tmesys.
