## THIRD AMENDMENT TO AGREEMENT NO. 32020

THIS THIRD AMENDMENT TO AGREEMENT NO. 32020 is made and entered, in duplicate, as of December 9, 2020 for reference purposes only, adopted by the City Council of the City of Long Beach at its meeting on August 14, 2018, by and between SPRINT SOLUTIONS, INC., a Delaware corporation ("Sprint"), whose address is 12502 Sunrise Valley Drive, Reston, Virginia, and the CITY OF LONG BEACH ("Client" or "City"), a municipal corporation.

WHEREAS, City and Sprint (the "Parties") entered into Agreement No. 32020 (the "Agreement") whereby Sprint agreed to provide cellular telephone and data services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term to June 30, 2020;

WHEREAS, the Parties entered into a Second Amendment to the Agreement to extend the term to December 31, 2020; and

WHEREAS, the State of California Contract No. 7-10-70-15 was extended, therefore, the Parties desire to extend the Agreement;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 2 of the Agreement is hereby amended to read as follows:
- "2. <u>TERM</u>. The term of this Agreement shall commence on December 14, 2010, and shall terminate on March 31, 2021. This Agreement may be terminated by Client for cause or convenience on thirty (30) days prior notice without penalty or further obligation after Client has paid for services rendered through the date of termination. Sprint may terminate this Agreement in accordance with California Agreement #7-10-70-15."
- 2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 32020 are ratified and confirmed and shall remain in full force and effect.
