1 FIRST AMENDMENT TO AGREEMENT NO. 36088

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 36088 is made and  
4 entered, in duplicate, as of April 12, 2023, for reference purposes only, pursuant to a minute  
5 order adopted by the City Council of the City of Long Beach at its meeting on July 6, 2021,  
6 by and between BURO HAPPOLD CONSULTING ENGINEERS, INC., a California  
7 corporation ("Consultant"), with a place of business at 800 Wilshire Boulevard, 16th Floor,  
8 Los Angeles, California 90017, and the CITY OF LONG BEACH, a municipal corporation  
9 ("City").

10 WHEREAS, City requires specialized services requiring unique skills to be  
11 performed in connection with as-needed professional engineering services ("Project"); and

12 WHEREAS, on July 6, 2021, the City Council adopted Specifications No.  
13 RFQ PW0-059 and awarded agreements for as-needed professional engineering services  
14 for a period of two (2) years, with the option to renew for three (3) additional one-year  
15 periods, at the discretion of the City Manager; and

16 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.  
17 36088 (the "Agreement") whereby Consultant agreed to provide these services; and

18 WHEREAS, the Parties desire to extend the term of the Agreement using the  
19 first one-year period option, and update the City's Representative in Exhibit C;

20 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
21 conditions herein contained, the Parties agree as follows:

22 1. Section 2 of the Agreement is hereby amended to read as follows.

23 "2. TERM. The term of this Agreement shall commence at midnight on  
24 August 1, 2021, and shall terminate at 11:59 p.m. on July 31, 2024, unless sooner  
25 terminated as provided in this Agreement, or unless the services or the Project is  
26 completed sooner. The term may be extended for two (2) additional one-year periods, at  
27 the discretion of the City Manager."


28 2. The City's Representative in Exhibit "C" to the Agreement is hereby

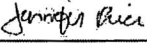
