Report on Tidelands Funds Update

DISCUSSION

Attached is the Quarterly Report prepared by Parks, Recreation and Marine Department staff for the Marine Advisory Commission. It contains all of the capital improvement projects of the Department in the Tidelands area. Many projects have funding from sources other than the Tidelands Fund, but nearly all of the projects do use some Tidelands Funds as part of the total funding.

Since the historical Reserves in the Tidelands Fund were depleted in 1994, the amount of Tidelands Fund support for capital projects has varied widely from year to year. This has delayed some projects that needed additional funding in years when little capital funding was available. It has also caused several projects intended to make the beaches and marinas more attractive to be delayed or discontinued, as funding for critical repairs was all that was available. Thus, despite the level of capital funding that has been allocated, there remains a large unmet need for capital funding in the beaches and marina areas. This is especially true of the beaches, as the marinas have restructured the revenue from slip rental and have become self-supporting. In contrast, the beaches have meager revenue generation and depend upon from other sources.

AquaLink Alamitos Bay Funded by: Transportation funds.

Description: Construct new dock for AquaLink at Alamitos Bay Landing Long Dock.

Status: Design complete. Construction bidding December 2006.

Stage: Construction design Original Completion: Summer 2005 NEW: July 2007

Beach Bike Path Oases Funded by: Tidelands Beaches and Waterways

Description: Construct rest areas with shade along the beach bike path.

Status: Coastal Commission approval for Vita Course.

Stage: Conceptual design Completion: Unscheduled

Beach Erosion Funded by: Tidelands Beaches and Waterways

Description: Maintain beach width by moving sand from areas of accretion to areas of erosion.

Status: Annual program, 2006 complete. Next year scheduled for February-March 2007.

Description: Mitigate bluff erosion with planting, terracing, re-sloping, geo-textiles, and/or structures.

Description: The project is the construction of a 3-acre passive park.

Status for Jack Nichol Park: PARK - Revised construction plans have been received from landscape architect. Grading quantities being revised for increased volume due to illegally dumped soil. Plans approved for permits. Landscape architect preparing corrections to construction specifications. Nearly

ready to bid.

Description: Detailed study of means of reducing beach erosion on the peninsula.

Rainbow Harbor Dock 9 Funded by: Prop C Transportation Funds

Description: Rebuild existing dock that has deteriorated due to heavier than intended use.

Status: Construction contract awarded. Construction to begin in January 2007.

Stage: Pre-Construction Original Completion: Fall 2004 NEW; Summer 2007

Rainbow Harbor Dock 8 Funded by: Tidelands Beaches and Waterways

Description: Replace temporary mooring dock

Status: Design complete. Contract for construction being prepared.

Stage: Pre-construction Completion: Summer 2007

Sand Bag Groins Funded by: Tidelands Beaches and Waterways

Description: Install four shoreline perpendicular sand bag groins, one bag high, 200 feet long.

Status: Contract is being finalized with engineer to design a second phase of bags.

Stage: Pre-design Completion: Unscheduled

Shoreline Marina Rebuilding Funded by: DBAW Loan

Description: Rebuild docks in Long Beach Shoreline Marina

Status: Construction underway. Month 22 of 28-month in water construction period.

Description: Relocate Basketball, Roller Hockey and Handball courts from the Bay Shore Playground area (Ocean Boulevard and 54th Place) to the Granada Avenue parking lot. The courts at the Bay Shore Playground area would be replaced with a passive seating and picnic area.

Status: Concept being reviewed with community before finalizing concept. Marine Advisory Commission has requested all beach-oriented projects be placed in single plan before recommending on concept.

Stage: Design

Completion: Unscheduled

Leeway Sailing Center Rebuilding

Funded by: Tidelands Fund (design only)

Description: Replace aging building with new structure of similar size and use.

Status: Preparations to hire an architect are underway.

Stage: Pre-design.

Completion: Unscheduled

Colorado Lagoon Remediation

Funded by: California Clean Beaches Program

Description: Implement the Colorado Lagoon Restoration Feasibility Study with such actions as diverting dry season storm drain runoff to the sewer system, dredging bottom sediment, cleaning and repairing the tidal connection culvert, grading and replanting banks and other actions.

Status: Some of the implementation actions have been funded. Grant agreements being executed and

construction design firm being hired.

Stage: Design

Completion: Unscheduled

Rainbow Lagoon Restoration

Funded by: Tidelands Funds (design only)

Description: Restore lagoon with deepening, repair and redesign to tidal connection, repair of adjacent walkway and lagoon edge.

Status: Preliminary concept reviewed favorably by regulatory agencies. Concept being refined for submittal

for regulatory approvals.

Completion: Unscheduled
