A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH COMPUTER AID, INC. TO PROVIDE MANAGED SERVICES **TECHNOLOGY** FOR INFORMATION AND STAFF AUGMENTATION, ON THE SAME **TERMS** AND CONDITIONS AFFORDED TO SOURCEWELL, A STATE OF MINNESOTA LOCAL GOVERNMENT UNIT AND SERVICE COOPERATIVE, IN A TOTAL ANNUAL AMOUNT NOT TO EXCEED \$1,250,000, UNTIL THE CURRENT CONTRACT EXPIRES ON SEPTEMBER 10, 2025, WITH THE OPTION TO RENEW FOR AS LONG AS THE SOURCEWELL CONTRACT IS IN EFFECT, AT THE DISCRETION OF THE CITY MANAGER

WHEREAS, the Charter of the City of Long Beach (the "City"), Section 1802. permits the City to purchase services, supplies, materials, equipment and labor with other government agencies by purchasing under their contracts on a voluntary and selective basis when authorized by resolution; and

WHEREAS, the City desires managed services for information technology and staff augmentation; and

WHEREAS, Sourcewell, a State of Minnesota local government unit and service cooperative, has a contract with Computer Aid, Inc. for IT Managed Service Provider and Staff Augmentation Solutions, Contract No. 071321-CAI ("Sourcewell Contract"); and

WHEREAS, the City's participation in the Sourcewell Contract will facilitate

the City's ability to provide managed services for information technology and staff augmentation as well as provide considerable cost benefits to the City; and

WHEREAS, if the City had to utilize a formal bid process rather than participate in the Sourcewell Contract considerably more funds would be required;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. The City Manager of the City is hereby authorized to enter an agreement with Computer Aid, Inc. to provide managed services for information technology and staff augmentation, of the same type and kind identified in the Sourcewell Contract except as modified by mutual agreement of the City and Computer Aid, Inc., in a total annual amount not to exceed One Million Two Hundred Fifty Thousand Dollars (\$1,250,000), until the current contract expires on September 10, 2022, with the option to renew for as long as the Sourcewell Contract is in effect, at the discretion of the City Manager.

Section 3. This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify the vote adopting this resolution.
