A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH HOLOGIC, INC., WITHOUT ADVERTISING FOR BIDS, FOR THE PURCHASE OF MOLECULAR DIAGNOSTIC TEST KITS FOR ONE YEAR IN AN AMOUNT NOT TO EXCEED **OPTION** \$250.000 WITH THE TO EXTEND THE CONTRACT TWO ADDITIONAL FOR ONE-YEAR **PERIODS** 

WHEREAS, the City's Department of Health and Human Services performs approximately 18,500 Chlamydia tests, 15,000 gonorrhea tests and 200 DNA mycobacteria identification tests each year; and

WHEREAS, the technology used by Hologic, Inc. for the Chlamydia and Gonorrhea testing methodology is proprietary and not available from another manufacturer; and

WHEREAS, Hologic, Inc. is the only company that produces molecular DNA probe test for the identification of mycobacteria; and

WHEREAS, as a result, no useful purpose would be served by advertising for bids for furnishing and delivering these testing kits and to do so would constitute an idle and useless act and an unnecessary expenditure of public funds because Hologic, Inc. is the only corporation, firm or individual that could or would bid for the furnishing of these testing kits to the City;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:
