THIRD AMENDMENT TO AGREEMENT NO. 35064

GROVE ST., ANAHEIM, CA 92806, and the CITY OF LONG BEACH ("City"), a municipal corporation.

WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 35064 ("Agreement") whereby Contractor agreed to provide Winchester ammunition; and

WHEREAS, the Parties entered into a First Amendment to extend the term of the Agreement and attach an updated rate schedule; and

WHEREAS, the Parties entered into a Second Amendment to extend the term of the Agreement for an additional one-year period and attach the updated rate schedule; and

WHEREAS, the Parties currently desire to extend the term of the Agreement for an additional one-year period and attached the updated rate schedule;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 3. of Agreement No. 35064 is hereby amended to read as follows:
- "3. The term of this Contract shall commence on October 1, 2018, and shall terminate at midnight on October 1, 2023, unless sooner terminated as provided herein. The City may terminate this Contract by giving thirty (30) days prior notice of termination to Contractor."
- 2. Exhibit "A-2" to Agreement 35064 is hereby amended and replaced with Exhibit "A-3", attached hereto and incorporated herein.


