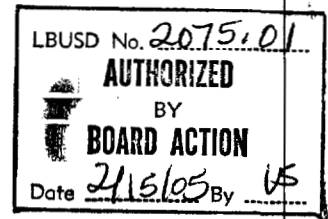


1 THIRD AMENDMENT TO AGREEMENT NO. 29299

3 THIS THIRD AMENDMENT TO AGREEMENT NO. 29299 is made and
4 entered, in duplicate, as of September 17, 2007, for reference purposes only, pursuant to
5 a minute order adopted by the City Council of the City of Long Beach at its meeting on
6 May 3, 2005, by and among LONG BEACH COMMUNITY SERVICES DEVELOPMENT
7 CORPORATION, INC. ("LBCSDC"), the CITY OF LONG BEACH ("City"), and the LONG
8 BEACH UNIFIED SCHOOL DISTRICT OF LOS ANGELES COUNTY ("District").

9 WHEREAS, Agreement No. 29299 was entered to define the collaborative
10 efforts of the parties through a Role of Men Academy; and

11 WHEREAS, the Section 5 of the Agreement stated that the parties shall
12 execute an amendment to identify the budget for each year of the Agreement and now
13 desire to do so;

14 NOW, THEREFORE, in consideration of the mutual terms and conditions in
15 the Agreement and herein, the parties agree as follows:

16 1. In accordance with Section 5 of Agreement No. 29299, the parties
17 agree to the following budgeted amounts: For the period from October 1, 2007 through
18 September 30, 2008, LBCSDC shall pay to the City on October 1, 2007, on January 1,
19 2008, on April 1, 2008 and on July 1, 2008 the sum of \$28,787.50 on each date. For the
20 same period, LBCSDC shall pay to the District on October 1, 2007 the sum of \$12,600.
21 And, LBCSDC shall retain the sum of \$22,250.

22 2. Except as expressly amended in this Third Amendment, all terms
23 and conditions in Agreement No. 29299 are ratified and confirmed and shall remain in full
24 force and effect.
