3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH DIRECTING THE LOS ANGELES
5 COUNTY AUDITOR-CONTROLLER TO INCLUDE ON THE
6 2010-2011 SECURED TAX ROLL CERTAIN
7 ASSESSMENTS MADE PURSUANT TO PROVISIONS OF
8 THE LONG BEACH MUNICIPAL CODE FOR WEED AND
9 DEBRIS REMOVAL, ADMINISTRATIVE CITATIONS AND
10 PENALTIES, SECURING OF BUILDINGS, AND
11 MONITORING OF VACATED BUILDINGS

13 WHEREAS, Chapters 8.56 (Weed Removal), 9.65 (Administrative
14 Citations and Penalties), 18.20 (Unsafe Buildings or Structures), and 18.21
15 (Maintenance of Long-Term Boarded and Vacated Buildings) of the Long Beach
16 Municipal Code provide a system for the City to levy, collect and recover costs
17 associated with removing weeds and debris from privately owned real property, unpaid
18 administrative citations and penalties, securing of buildings, and monitoring of vacant
19 buildings; and

20 WHEREAS, the City's Building Official is required to certify to the City
21 Treasurer-Tax Collector the amount of the weed abatement, unpaid administrative
22 citations and penalties, securing of buildings, and monitoring of vacant buildings; and

23 WHEREAS, the City's Building Official has certified to the City Treasurer-
24 Tax Collector unpaid charges in connection with the weed abatement, administrative
25 citations and penalties, securing of buildings, and monitoring of vacant buildings which
26 should be entered upon the secured tax roll and collected in the same manner as ad
27 valorem taxes.

28 NOW, THEREFORE, the City Council of the City of Long Beach resolves

1 as follows:

2 Section 1. The Los Angeles County Auditor-Controller is hereby
3 authorized and requested to include on the 2011-2012 secured tax roll the delinquent
4 assessment charges, and penalties, if any, for each of the described parcels of real
5 property set forth in Exhibits "A", "B", "C", and "D" attached hereto and made a part
6 hereof. The county parcel number and the total unpaid assessment, together with
7 interest thereon, and the situs address of the real property are set forth on each exhibit.
8 Only the amount set forth in the third column entitled "Amount" should be entered as
9 charges due the City of Long Beach on the real property to which the amount refers.
10 The Los Angeles County Auditor-Controller is directed to collect said charges in the
11 same manner as ad valorem taxes.

12 Section 2. The Director of Financial Management is directed to transmit
13 to the County Auditor-Controller a certified copy thereof on or before July 31, 2011.

14 Section 3. This resolution shall take effect immediately upon its
15 adoption by the City Council, and the City Clerk shall certify the vote adopting this
16 resolution.
