9 WHEREAS, in accordance with the Long Beach City Charter, the City
10 Council has called a municipal primary nominating election to be held in the City of Long
11 Beach on April 8, 2014, for the City Council offices in Council Districts One, Three, Five,
12 Seven, and Nine, and for the offices of Mayor, City Attorney, City Auditor, and City
13 Prosecutor, and for offices of the Board of Trustees of the Long Beach Community
14 College District and Board of Education of the Long Beach Unified School District; and

15 WHEREAS, in accordance with City Charter Section 1907, the City Clerk
16 has submitted to the City Council a certified list of the candidates which have been duly
17 nominated as required by law for the elective offices to be voted on at said election, and
18 the names are listed for each such office in the order of the randomized alphabet
19 selected by the Secretary of State in a drawing held on January 16, 2014, pursuant to
20 California Elections Code Section 13112.

21 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
22 follows:

28 by the City Council, and the City Clerk shall certify the vote adopting this resolution.



RE: April General Law City Elections: Randomized Alphabet Drawing

In accordance with Elections Code section 13112(b)(1)(A), the Secretary of State's office conducted a drawing of the letters of the alphabet to determine the randomized alphabet for use in the above election. Listed below is the official order of letters for use in determining placement of candidates' names on the ballot.

Please note that this alphabet is to be applied THROUGHOUT the candidate's entire last name, so if more than one candidate's surname begins with the same letter, the second letter of the surname determines who goes first, according to where the second letter of the name appears in the random alphabet. For example, if two candidates with the surname of Campbell and Carlson are running for the same office, their order on the ballot will depend on the order in which the letters "M " and "R" were drawn in the randomized alphabet drawing.
