**Subject:** Funds Transfer to Long Beach Lesbian & Gay Pride Inc. for the 39<sup>th</sup> Annual Long Beach Pride

### **RECOMMENDATION:**

Increase appropriations in the General Fund Group in the City Manager Department by \$2,500, offset by the First Council District One-time District Priority Funds, transferred from the Citywide Activities Department, to provide a donation to Long Beach Lesbian & Gay Pride Inc; and,

Decrease appropriations in the General Fund Group in the Citywide Activities Department by \$2,500 to offset a transfer to the City Manager Department.

### **DISCUSSION:**

This year Long Beach Lesbian & Gay Pride Inc, a 501(c)3 organization, will be producing the 39<sup>th</sup> Annual Long Beach Pride which will consist of Long Beach Teen Pride on Friday, July 8<sup>th</sup>, the Long Beach Pride Festival on Saturday, July 9<sup>th</sup> and Sunday, July 10<sup>th</sup>, as well as the Long Beach Pride Parade on Sunday, July 10<sup>th</sup>. Each of these events are a celebration of the LGBTQ+ community as Long Beach Lesbian & Gay Pride Inc. works to produce and support activities that educate, encourage, and celebrate Pride, inclusion, and respect for humanity.

Recent events have shown that rights for individuals in our country are not certain. As a city it is important that we work with the LGBTQ+ community and Long Beach Lesbian & Gay Pride Inc. to work towards that better future where all members of society are included and respected. The 39<sup>th</sup> Annual Long Beach Pride is a significant cultural and educational experience in Long Beach, and it is appropriate for the City Council to support Long Beach Lesbian & Gay Pride Inc. as they produce the 39<sup>th</sup> Annual Long Beach Pride.

This matter has been reviewed by Budget Manager Grace H. Yoon on June 27, 2022.

### **FISCAL IMPACT:**

This recommendation requests the City Manager to provide a contribution to Long Beach Lesbian & Gay Pride Inc. The total appropriation increase of \$2,500 in the General Fund Group in the City Manager Department will be offset by a decrease of appropriation of First Council District One-

time District Priority Funds in the General Fund Group in the Citywide Activities Department. The requested action is anticipated to require a minimal level of staff hours beyond the normal budgeted scope of duties and expected to have minimal impact on existing City Council priorities.
