WHEREAS, City requires specialized services requiring unique skills to be performed in connection with Emergency Occupancy related to COVID-19, and is directly related to that emergency and necessary for the preservation of public health and safety; and

WHEREAS, City and Owner (the "Parties") entered into Agreement No. 35632 (the "Agreement") whereby Owner agreed to provide these services; and

WHEREAS, the Parties desire to amend the terms of the Agreement;

- "2. <u>TERM</u> The term of this Agreement shall commence on April 1, 2021, and shall continue for a term of six (6) months, with such rights of termination as may be hereinafter expressly set forth."
