## RESOLUTION NO. RES-09-0161

CITY OF LONG BEACH, CALIFORNIA, GRANTING
PERMISSION TO MEMBERS OF THE PUBLIC TO PARK
IN THE CITY OWNED PARKING LOTS LOCATED ON
BROADWAY BETWEEN LONG BEACH BOULEVARD AND
ELM AVENUE AND ESTABLISHING FEES WITH
RESPECT THERETO

A RESOLUTION OF THE CITY COUNCIL OF THE

WHEREAS, Section 21113 of the California Vehicle Code prohibits any person from parking any vehicle upon the property under the direct control of the City, except with the permission of, and subject to such conditions and regulations as may be imposed by the City; and

WHEREAS, on October 4, 2005, the City Council adopted Resolution No. RES-05-0107, which established parking fees for the City owned lots located at Broadway between Long Beach Boulevard and Elm Avenue; and

WHEREAS, the City now desires to modify such fees; and

WHEREAS, the City gave public notice of the proposed fees for parking on City owner lots located at Broadway between Long Beach Boulevard and Elm Avenue, and a public hearing was held on December 15, 2009, concerning such fees;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. Any person may park a vehicle on the City owned lots located at Broadway between Long Beach Boulevard and Elm Avenue, subject to the following fees:

- 1. Basic Rate: \$5.00 per day every day of the week.
- 2. Residential (limited use) Monthly Parking Rates: \$35.00 per month.
