

1 FOURTH AMENDMENT TO AGREEMENT NO. 33774

3 THIS FOURTH AMENDMENT TO AGREEMENT NO. 33774 is made and
4 entered, in duplicate, as of January 17, 2017, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 January 6, 2015, by and between CSG CONSULTANTS, INC., a California corporation
7 ("Consultant"), with a place of business at 550 Pilgrim Drive, Foster City, California 94404,
8 and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City requires specialized services requiring unique skills to be
10 performed in connection with as-needed plan review and inspection services; and

11 WHEREAS, City and Consultant entered into Agreement No. 33774 (the
12 "Agreement") whereby Consultant agreed to provide these services; and

13 WHEREAS, City and Consultant entered into a First Amendment to the
14 Agreement to increase the not to exceed amount to \$80,000; and

15 WHEREAS, City and Consultant entered into a Second Amendment to the
16 Agreement to increase the not to exceed amount to \$140,000; and

17 WHEREAS, City and Consultant entered into a Third Amendment to the
18 Agreement to increase the not to exceed amount to \$160,000; and

19 WHEREAS, City and Consultant desire to increase the total not to exceed
20 amount to \$235,000 and extend the term for an additional one (1) year period;

21 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
22 conditions herein contained, the parties agree as follows:

23 1. Section 1.A. of the Agreement is hereby amended to read as follows:

24 "A. Consultant shall furnish specialized services more particularly
25 described in Exhibit "A", attached to this Agreement and incorporated by this reference, in
26 accordance with the standards of the profession, and City shall pay for these services in
27 the manner described below, an amount not to exceed Two Hundred Thirty-Five Thousand
28 Dollars (\$235,000), at the rates or charges shown in Exhibit "B"."

2. Section 2 of the Agreement is hereby amended to read as follows:

"2. TERM. The term of this Agreement shall commence at midnight on January 7, 2015, and shall terminate at 11:59 p.m. on January 6, 2018, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The parties have the option to extend the term one (1) additional one-year period."

3. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 33774 are ratified and confirmed and shall remain in full force and effect.
