

1 SECOND AMENDMENT TO AGREEMENT NO. 33840

3 THIS SECOND AMENDMENT TO AGREEMENT NO. 33840 is made and
4 entered, in duplicate, as of March 8, 2018, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on April
6 7, 2015, by and between LG2WB ENGINEERS, INC. DBA LINSKOTT, LAW &
7 GREENSPAN ENGINEERS, a California corporation ("Consultant"), with a place of
8 business at 2 Executive Circle, Suite 250, Irvine, California 92614, and the CITY OF
9 LONG BEACH, a municipal corporation ("City").

10 WHEREAS, City requires specialized services requiring unique skills to be
11 performed in connection with as-needed traffic engineering, transportation planning and
12 related technical and professional services; and

13 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
14 33840 (the "Agreement") whereby Consultant agreed to provide these services; and

15 WHEREAS, the Parties entered into a First Amendment to decrease the
16 amount by \$100,000 for a total not to exceed amount of \$300,000; and

17 WHEREAS, the Parties desire to extend the term one (1) additional one-
18 year period;

19 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
20 conditions herein contained, the Parties agree as follows:

- 21 1. Section 2 of the Agreement is hereby amended to read as follows:
- 22 "2. TERM. The term of this Agreement shall commence at midnight on
23 June 1, 2015, and shall terminate at 11:59 p.m. on May 31, 2019, unless sooner
24 terminated as provided in this Agreement, or unless the services or the Project is
25 completed sooner. The Parties have the option to extend the term one (1) additional one-
26 year period."
- 27 2. Except as expressly modified herein, all of the terms and conditions
28 contained in Agreement No. 33840 are ratified and confirmed and shall remain in full
