Narrative

On 02/20/2016, while working uniform patrol as unit DE14 my partner at the time (Officer R. Beach #10071) and I (Officer B. Barajas #6234) were patrolling the Willow Street corridor. We drove to the 710 Bar, located at 329 W. Willow Street, checked the parking lot for illegal activity. After checking the 710 Bar, we drove to Miko's Bar, located at 710 W. Willow Street. We drove westbound the east-west alley behind the bar and saw a white vehicle parked behind the bar with two occupants inside the vehicle. We were not sure how long the vehicle and the occupants were inside of the car.

After checking the alley and the rear parking lot of Miko's Bar, we drove to the front of the business. I noticed two uniform security guards standing by the front entrance. Standing by the front door was the female security guard, her counterpart was a male subject who was standing east of the front door. I walked over to the front door and greeted the security guard. As I got closer to the front door I could hear loud music from inside the bar. I walked inside the bar and the music amplified, which required me to turn my police radio volume up in order to hear my radio. I noticed approximately 8 patrons by the bar. Behind the bar was a female bartender and west of the bar, closer to the front door was a live DJ with a turntable and a larger speaker next to him.

I know that Miko's Bar is a COPS location and I know that Miko's Bar needs a entertainment permit for have a live DJ. I approached the DJ (later identified as Jermaine Donalson 11/21/1974) and asked him to turn down the music. The music was so loud I had to ask Donaldson twice to turn down the music before he could hear me. Donaldson said he was hired by the owner and showed up at 1930 hours to play live music.

I asked the bartender to direct me to the manager. I was escorted to an office where I met Damitresse Lynne

Yancy. I asked Yancy if she was allowed to have a live DJ inside the bar. Yancy said she was not allowed to have a DJ without a permit. I asked Yancy if she had an entertainment permit for the DJ. Yancy did not have a permit and said that she was only doing what the other bars are doing along the Willow Street corridor. Yancy explained to me that she is trying to run a successful business, but it's difficult to do when strict rules exist in the City of Long Beach.

I asked Yancy what time the DJ arrived at the bar to play live music. Yancy said the DJ arrived at approximately 2230 hours. I issued Yancy a citation [B768086] for being in violation of 5.72.110(a) LBMC.

Yancy voluntarily signed the citation and was given a copy of the citation.
