

1 SECOND AMENDMENT TO AGREEMENT NO. 34385

3 THIS SECOND AMENDMENT TO AGREEMENT NO. 34385 is made and  
4 entered, in duplicate, as of January 22, 2018, for reference purposes only, pursuant to a  
5 minute order adopted by the City Council of the City of Long Beach at its meeting on July  
6 5, 2016, by and between PSOMAS, a California corporation ("Consultant"), with a place of  
7 business at 3 Hutton Centre Drive, Suite 200, Santa Ana, California 92707, and the CITY  
8 OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City requires specialized services requiring unique skills to be  
10 performed in connection with as-needed public works construction management and  
11 inspection services; and

12 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.  
13 34385 (the "Agreement") whereby Consultant agreed to provide these services; and

14 WHEREAS, the Parties entered into a First Amendment to the Agreement to  
15 add \$1,000,000 for a total not to exceed amount of \$2,000,000; and

16 WHEREAS, the Parties desire to increase the Agreement amount by  
17 \$1,000,000 for a total not to exceed amount of \$3,000,000;

18 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
19 conditions herein contained, the Parties agree as follows:

20 1. Section 1.A. of the Agreement is hereby amended to read as follows:

21 "A. Consultant shall furnish specialized services more particularly  
22 described in Exhibit "A", attached to this Agreement and incorporated by this  
23 reference, in accordance with the standards of the profession, and City shall pay for  
24 these services in the manner described below, not to exceed Three Million Dollars  
25 (\$3,000,000), at the rates or charges shown in Exhibit "B"."

26 2. Except as expressly modified herein, all of the terms and conditions  
27 contained in Agreement No. 34385 are ratified and confirmed and shall remain in full force  
28 and effect.


