3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH DIRECTING THE LOS ANGELES
5 COUNTY AUDITOR-CONTROLLER TO INCLUDE ON THE
6 2008-2009 REAL AND SECURED TAX ROLL CERTAIN
7 ASSESSMENTS MADE PURSUANT TO THE PROVISIONS
8 OF THE LONG BEACH MUNICIPAL CODE FOR REMOVING
9 WEEDS AND DEBRIS (LOT CLEANING CHARGES)

11 WHEREAS, Section 8.56 of the Long Beach Municipal Code provides a
12 system for levy and collection to cover the cost of removing weeds and debris by the City
13 from privately owned real property; and

14 WHEREAS, the City's Building Official is required to certify to the City
15 Treasurer-Tax Collector the amount of the unpaid lot cleaning charges and interest for
16 delinquency; and

17 WHEREAS, the City's Building Official has certified to the City Treasurer-
18 Tax Collector unpaid lot cleaning charges and interest for delinquency which should be
19 entered upon the real and secured tax roll;

20 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
21 follows:

22 Section 1. The County Auditor-Controller is hereby authorized and
23 requested to include on the 2008-2009 real and secured tax roll the delinquent
24 assessment charges, and penalties, if any, for each of the described pieces of property
25 set forth in Exhibit "A" attached hereto and made a part hereof. The county parcel
26 number and the total unpaid assessment, together with interest thereon, and the situs
27 address of the property is set forth in Exhibit "A." Only the amount set forth in the third
28 column entitled "Amount" should be entered as charges due the City of Long Beach on

1 the real property to which the amount refers. The County Auditor-Controller is directed to
2 collect said charges in the same manner as ad valorem taxes.

3 Section 2. The Director of Financial Management is directed to transmit
4 to the County Auditor-Controller a certified copy thereof on or before July 31, 2008.


5 Section 3. This resolution shall take effect immediately upon its adoption
6 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
