

1 SECOND AMENDMENT TO AGREEMENT NO. 33413

3 THIS SECOND AMENDMENT is made and entered, in duplicate, as of
4 June 1, 2015, pursuant to a minute order adopted by the City Council of the City of Long
5 Beach at its meeting on January 21, 2014, by and between C3G SOLUTIONS, INC., a
6 Florida corporation, located at 15925 Carmenita Road, Cerritos, CA 90703
7 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

8 WHEREAS, the City requires specialized services requiring unique skills to
9 be performed on an as-needed basis in connection with professional and technical
10 services for information technology projects and systems ("Project"); and

11 WHEREAS, now the parties desire to increase the amount of Agreement
12 No. 33413;

13 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
14 conditions in this Agreement, the parties agree as follows:

15 1. Section 1.A. of Agreement No. 33413 is amended to read as follows:

16 "1.A. SCOPE OF WORK OR SERVICES.

17 A. Consultant shall furnish specialized services more particularly
18 described in Exhibit "A", attached to this Agreement and incorporated by this
19 reference, in accordance with the standards of the profession, and City shall pay
20 for these services in the manner described below, in an annual amount not to
21 exceed Three Hundred Thousand Dollars (\$300,000.00), at the rates or charges
22 shown in Exhibit "A".

23 2. Except as expressly amended herein all of the terms, covenants, and
24 conditions of Agreement No. 33413 as amended shall remain in full force and effect.
