3 THIS EIGHTH AMENDMENT TO AGREEMENT NO. 33453 is made and
4 entered, in duplicate, as of March 11, 2020, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on March
6 10, 2020, by and between BUNNELL ENTERPRISES, INC. DBA TOTAL NETWORK
7 SOLUTIONS, a California corporation, located at 5150 E. Pacific Coast Highway, Suite
8 530, Long Beach, CA 90804 ("Contractor"), and the CITY OF LONG BEACH, a municipal
9 corporation ("City").

10 WHEREAS, City and Contractor (the "Parties") entered into Agreement No.
11 33453 (the "Agreement") whereby Contractor agreed to provide professional and technical
12 services for information technology projects and systems on an as-needed basis; and

13 WHEREAS, the Parties entered into a First Amendment to the Agreement to
14 increase the total not to exceed amount to \$150,000; and

15 WHEREAS, the Parties entered into a Second Amendment to the Agreement
16 to increase the total not to exceed amount to \$350,000 and extend the term to January 22,
17 2017; and

18 WHEREAS, the Parties entered into a Third Amendment to the Agreement
19 to increase the total not to exceed amount to \$500,000; and

20 WHEREAS, the Parties entered into a Fourth Amendment to the Agreement
21 to increase the total not to exceed amount to \$700,000 and extend the term to January 22,
22 2018; and

23 WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to
24 increase the total not to exceed amount to \$800,000 and extend the term to January 22,
25 2019; and

26 WHEREAS, the Parties entered into a Sixth Amendment to the Agreement
27 to increase the total not to exceed amount to \$900,000 and extend the term to October 22,

1 WHEREAS, the Parties entered into a Seventh Amendment to the
2 Agreement to add \$50,000 to the Agreement for a total not to exceed amount of \$950,000
3 and extend the term to March 22, 2020; and

4 WHEREAS, the Parties desire to extend the term to July 22, 2020;

5 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
6 conditions herein contained, the Parties agree as follows:

7 1. Section 2 of the Agreement is hereby amended to read as follows:

8 "2. TERM. The term of this Agreement shall commence on April 22, 2014,
9 and shall terminate on July 22, 2020, unless sooner terminated as provided in this
10 Agreement, or unless the services or the Project is completed sooner."

11 2. Except as expressly modified herein, all of the terms and conditions
12 contained in Agreement No. 33453 are ratified and confirmed and shall remain in full force
13 and effect.
