

1 FIRST AMENDMENT TO AGREEMENT NO. 30623

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 30623 is made and
4 entered, in duplicate, as of December 14, 2009 for reference purposes only, pursuant to
5 a minute order adopted by the City Council of the City of Long Beach at its meeting held
6 on September 4, 2007, by and between WILLDAN, a California corporation
7 ("Consultant"), with a place of business at 2401 E. Katella Avenue, Suite 300, Anaheim,
8 California 92806, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, the parties entered Agreement No. 30623 whereby Consultant
10 agreed to perform As-Needed Certified Materials Testing and Inspection, and
11 Construction Management Services for Public Works Infrastructure and Facility Projects;
12 and

13 WHEREAS, the parties desire to increase the Agreement amount by
14 \$1,200,000;

15 NOW, THEREFORE, in consideration of the mutual terms and conditions in
16 the Agreement and in this First Amendment, the parties agree as follows:

17 1. Section 1.A. of Agreement No. 30623 is hereby amended to read as
18 follows:

19 "1. SCOPE OF WORK OR SERVICES.

20 A. Consultant shall furnish specialized services more particularly set
21 forth in Exhibit "A", attached hereto and incorporated herein by this reference, in
22 accordance with the standards of the profession, and City shall pay for said services in
23 the manner described below, not to exceed \$2,950,000.00, at the rates or charges
24 described in Exhibit "A".

25 2. Except as expressly amended in this First Amendment, all terms and
26 conditions in Agreement No. 30623 are ratified and confirmed and shall remain in full
27 force and effect.
