14	add a one time-contract authority of \$300,000 for integration services for the Long Beach
15	Water Department; and
16	WHEREAS, the Parties entered into a Second Amendment to the Agreement
17	to extend the term to September 30, 2021 and increase the annual amount by \$425,200,
18	with a ten percent contingency in the amount of \$271,130, for a revised not to exceed
19	annual amount of \$2,982,430; and
20	WHEREAS, the Parties entered into a Third Amendment to the Agreement
21	to extend the term to September 30, 2022 and add \$2,982,430; and
22	WHEREAS, the Parties entered into a Fourth Amendment to extend the term
23	to September 30, 2023 and increase the contract for an annual amount not to exceed
24	\$2,550,295; and
25	WHEREAS, the Parties desire to extend the term one (1) additional one-year
26	period and add the authorized 5% annual increase in the amount of \$127,514.75, for a
27	revised not to exceed annual amount of \$2,677,809, and

"A. Contractor shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Four Million Forty-Four Thousand Five Hundred Ninety-Five Dollars (\$4,044,595) for the term October 1, 2017 to September 30, 2018; a one-time fee of Three Hundred Thousand Dollars (\$300,000) to assist with the Long Beach Water Department's Advanced Metering Infrastructure system; an annual amount not to exceed Two Million Two Hundred Eighty-Six Thousand One Hundred Dollars (\$2,286,100) from October 1, 2018 to September 30, 2020; an annual amount not to exceed Two Million Nine Hundred Eighty-Two Thousand Four Hundred Thirty Dollars (\$2,982,430) from October 1. 2020 to September 2022; and an annual amount of Two Million Four Hundred Twenty-Eight Thousand Eight Hundred Fifty-Two Dollars (\$2,428,852), with a five percent (5%) contingency in the amount of One Hundred Twenty-One Thousand Four Hundred Forty-Three Dollars (\$121,443), for a revised not to exceed annual amount of Two Million Five Hundred Fifty Thousand Two Hundred Ninety-Five Dollars (\$2,550,295) from October 1, 2022 to September 30, 2023; and an annual amount_of_Two_Million_Five_Hundred_Fifty_Thousand_Two_Hundred_Ninety-Five Dollars (\$2,550,295), with a five percent (5%) increase in the amount of One Hundred Twenty-Seven Thousand Five Hundred Fourteen Dollars (\$127,514), for a revised not to exceed annual amount of Two Million Six Hundred Seventy-Seven Thousand Eight Hundred Nine Dollars (\$2,677,809) from October 1, 2023 to September 30, 2024, at the rates or charges shown in Exhibit "B"."

2. Section 2 of the Agreement is hereby amended to read as follows:

"2. <u>TERM</u>. The term of this Agreement shall commence at midnight on October 1, 2017, and shall terminate at 11:59 p.m. on September 30, 2024, unless sooner

terminated as provided in this Agreement, or unless the services or the Project is 1 2 completed sooner. The term may be extended for one (1) additional one-year periods, at 3 the discretion of the City Manager."

Except as expressly amended herein, all terms and conditions in 4 3. 5 Agreement No. 34740 are ratified and confirmed and shall remain in full force and effect. 6 IN WITNESS WHEREOF, the Parties have caused this document to be duly 7 executed with all formalities required by law as of the date first stated above.
