1 FOURTH AMENDMENT TO AGREEMENT NO. 33843

3 THIS FOURTH AMENDMENT TO AGREEMENT NO. 33843 is made and
4 entered, in duplicate, as of April 22, 2020 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on April
6 21, 2020, by and between KOA CORPORATION, a California corporation ("Consultant"),
7 with a place of business at 2141 West Oranewood Avenue, Suite A, Orange, California
8 92868, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
10 33843 (the "Agreement") whereby Consultant agreed to provide as-needed traffic
11 engineering, transportation planning and related technical and professional services; and

12 WHEREAS, the Parties entered into a First Amendment to the Agreement
13 to increase the amount by \$200,000 for a total not to exceed amount of \$800,000; and

14 WHEREAS, the Parties entered into a Second Amendment to the
15 Agreement to increase the amount by \$300,000 for a total not to exceed amount of
16 \$1,100,000 and extend the term to May 31, 2019; and

17 WHEREAS, the Parties entered into a Third Amendment to the Agreement
18 to increase the amount by \$350,000 for a total not to exceed amount of \$1,450,000 and
19 extend the term to May 31, 2020; and

20 WHEREAS, the Parties desire to add \$400,000 to the Agreement for a total
21 not to exceed amount of \$1,850,000 and extend the term one (1) additional one-year
22 period;

23 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
24 conditions herein contained, the Parties agree as follows:

25 1. Section 1.A. of the Agreement is hereby amended to read as follows:

26 "A. Consultant shall furnish specialized services more particularly
27 described in Exhibit "A", attached to this Agreement and incorporated by this
28 reference, in accordance with the standards of the profession, and City shall pay

1 for these services in the manner described below, not to exceed One Million Eight
2 Hundred Fifty Thousand Dollars (\$1,850,000), at the rates or charges shown in
3 Exhibit "B".

4 2. Section 2 of the Agreement is hereby amended to read as follows:

5 "2. TERM. The term of this Agreement shall commence at midnight on
6 June 1, 2015, and shall terminate at 11:59 p.m. on May 31, 2021, unless sooner
7 terminated as provided in this Agreement, or unless the services or the Project is
8 completed sooner."

9 3. Except as expressly modified herein, all of the terms and conditions
10 contained in Agreement No. 33843 are ratified and confirmed and shall remain in full
11 force and effect.


