WHEREAS, City and Developer (the "Parties") executed that certain Agreement to Negotiate Exclusively dated October 31, 2022 (the "ENA"), for the purchase and development of 6845 Atlantic Ave, more particularly described in the ENA (the "Property"); and

WHEREAS, the Parties entered into a First Amendment to the ENA to extend the term to October 31, 2023; and

WHEREAS, the Parties desire to amend the ENA by extending the term an additional ninety (90) days, with a 90-day renewal option;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. The initial one hundred eighty (180) day term of the ENA, as previously extended for an additional one hundred eighty (180) days, is hereby extended for an additional period of ninety (90) days commencing on November 1, 2023, and ending on January 31, 2024. The Parties shall have one option to extend the term of the ENA for an additional ninety (90) days.
- 2. Except as amended by this Amendment, the ENA remains unchanged and in full force and effect.
