3 THIS THIRD AMENDMENT TO AGREEMENT NO. 32444 is made and
4 entered, in duplicate, as of December 9, 2015 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting held on
6 December 20, 2011 and a minute order adopted by the Board of Trustees of the Long
7 Beach Community College District at its meeting held on October 25, 2011, by and
8 LONG BEACH COMMUNITY COLLEGE DISTRICT, a public corporation whose address
9 is 4901 E. Carson Street, Long Beach, California 90808 ("District"), and the CITY OF
10 LONG BEACH, a municipal corporation ("City").

11 WHEREAS, City collects parking citation fines and forfeitures through the
12 use of an automated parking system; and

13 WHEREAS, District has a parking enforcement program on its campuses
14 and has requested the City to process District's parking citations; and

15 WHEREAS, the parties entered Agreement No. 32444 whereby City agreed
16 to provide such services; and

17 WHEREAS, the parties desire to extend the term of the Agreement;

18 NOW, THEREFORE, in consideration of the mutual terms and conditions in
19 the Agreement and in this Third Amendment, the parties agree as follows:

20 1. Section 3.A of Agreement No. 32444 is hereby amended to read as
21 follows:

22 "3. TERM AND TERMINATION.

23 A. The term of this Agreement shall commence at midnight on
24 December 27, 2011, and shall terminate at 11:59 p.m. on December 26, 2016, unless
25 sooner terminated as provided in this Agreement."

26 2. Except as expressly amended in this Third Amendment, all terms
27 and conditions in Agreement No. 32444 are ratified and confirmed and shall remain in full
28 force and effect.
