## CONTRACT CHANGE ORDER AUTHORIZATION NO. 12

In accordance with procedures for changes in the work as established in the specifications, you are authorized to do the following:

Time extensions will be considered under separate cover only with a reviewed time impact analysis based on observations of as-built conditions.

PCO 012 – Credit for Deletion of Bubble Wall: Per OPR 005 and Bulletin 9 provide a credit for all labor, materials, equipment, transportation and incidentals for the original Bubble Wall on the North Elevation. As a point of clarification this credit excludes the costs for the curtainwall assembly already included in Work.
 The Contractor shall provide this work as directed by the City Engineer on a lump sum basis, for the cost of \_\_\_\_\_\_\_\_(\$ 26,734.91)

PCO 029 – Bubble Wall Revisions less Openings: Per Bulletin 9 provide all labor, materials, equipment, transportation and incidentals to provide all other Work for the bubble wall modifications. As a point of clarification this CCO excludes the costs for the additional door, hardware, frame and opening at the new Bubble Wall already included in CCO 011.
 The Contractor shall provide this work as directed by the City Engineer on a lump sum basis, for the cost of \_\_\_\_\_\_\_\$143,057.32
