

1 EIGHTH AMENDMENT TO AGREEMENT NO. 33387

3 THIS EIGHTH AMENDMENT TO AGREEMENT NO. 33387 is made and
4 entered, in duplicate, as of January 11, 2018, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 October 3, 2017, by and between APOLLO PROFESSIONAL SOLUTIONS, a
7 Massachusetts corporation, with offices located at 4010 Watson Plaza Dr., Suite 138,
8 Lakewood, California 90712 ("Consultant"), and the CITY OF LONG BEACH, a municipal
9 corporation ("City").

10 WHEREAS, the City requires specialized services requiring unique skills to
11 be performed on an as-needed basis in connection with professional and technical services
12 for information technology projects and systems; and

13 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
14 33387 (the "Agreement") whereby Consultant agreed to provide these services; and

15 WHEREAS, the Parties entered into a First Amendment to the Agreement to
16 clarify the terms of the Agreement; and

17 WHEREAS, the Parties entered into a Second Amendment to the Agreement
18 to extend the term and increase the total not to exceed amount to \$500,000; and

19 WHEREAS, the Parties entered into a Third Amendment to the Agreement
20 to increase the total not to exceed amount to \$600,000; and

21 WHEREAS, the Parties entered into a Fourth Amendment to the Agreement
22 to increase the total not to exceed amount to \$800,000; and

23 WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to
24 increase the total not to exceed amount to \$1,000,000; and

25 WHEREAS, the Parties entered into a Sixth Amendment to the Agreement
26 to increase the total not to exceed amount to \$1,500,000 and extend the term; and

27 WHEREAS, the Parties entered into a Seventh Amendment to the
28 Agreement to increase the total not to exceed amount to \$2,000,000; and

1 WHEREAS, the Parties desire to add \$1,000,000 for a total not to exceed
2 amount of \$3,000,000 and extend the term one (1) additional one-year period;

3 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
4 conditions herein contained, the Parties agree as follows:

5 1. Section 1.A of the Agreement is hereby amended to read as follows:

6 "A. Consultant shall furnish specialized services more particularly
7 described in Exhibit "A", attached to this Agreement and incorporated by this
8 reference, in accordance with the standards of the profession, and City shall pay for
9 these services in the manner described below, a total not to exceed contract amount
10 of Three Million Dollars (\$3,000,000), at the rates or charges shown in Exhibit "A"."

11 2. Section 2 of the Agreement is hereby amended to read as follows:

12 "2. TERM. The term of this Agreement shall commence on February 24,
13 2014, and shall terminate on January 22, 2019, unless sooner terminated as provided in
14 this Agreement, or unless the services or the Project is completed sooner."

15 3. Except as expressly modified herein, all of the terms and conditions
16 contained in Agreement No. 33387 are ratified and confirmed and shall remain in full force
17 and effect.
