RESOLUTION NO. RES-10-0007

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO SUBMIT AN APPLICATION FOR AND ENTER INTO AN AGREEMENT FOR GRANT FUNDS FOR THE BICYCLE TRANSPORTATION ACCOUNT GRANT PROGRAM

WHEREAS, the California Streets and Highway Code Section 893 requires the California Department of Transportation ("Caltrans") to make funds available to city and county projects that improve safety and convenience for bicycle commuters; and

WHEREAS, Caltrans issued a call for applications to provide funding for bicycle projects that are included within cities' adopted Bicycle Master Plans; and

WHEREAS, the City of Long Beach desires to receive Bicycle Transportation Account Grant funds to complete gaps in the Long Beach bicycle network at various locations;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. That the filing of an application for Four Hundred Thirty-Three Thousand Five Hundred Dollars (\$433,500) in grant funds from the Caltrans Bicycle Transportation Account Grant Program, with a fifteen percent (15%) local match of Seventy-Six Thousand Five Hundred Dollars (\$76,500).

Section 2. The City certifies that it has or will have funds available from the City's bicycle transportation funding from the Transportation Development Act Fiscal Year 2011 allocation to fulfill Caltran's local matching requirements.

Section 3. The City Manager is authorized to execute and submit all documents including, but not limited to, applications, agreements, amendments and

1 payment requests which may be necessary.


2 Section 4. This resolution shall take effect immediately upon its adoption
