FIRST AMENDMENT TO AGREEMENT NO. 35424

THIS FIRST AMENDMENT TO AGREEMENT NO. 35424 is made and entered, in duplicate, as of December 2, 2020 for reference purposes only, pursuant to Resolution No. RES-19-0172, adopted by the City Council of the City of Long Beach at its meeting held on November 12, 2019, by and between BRÜEL & KJAER EMS INC., a Delaware corporation ("Supplier"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Supplier (the "Parties") entered into Agreement No. 35424 (the "Agreement") to provide maintenance, upgrade and support of the Long Beach Airport Noise and Operations Monitoring System (ANOMS) dated December 1, 2019; and

WHEREAS, the Parties desire to amend the Agreement to exercise City's first option to extend the term and increase the total not to exceed amount:

NOW, THEREFORE, in consideration of the terms and conditions contained herein, City and Supplier agree as follows:

- 1. This Amendment shall be effective as of the date on which this Amendment is executed by both parties (the "Effective Date").
- 2. The term of the Agreement shall be extended commencing at 12:01 a.m. on December 1, 2020, and shall terminate at midnight on November 30, 2021, unless sooner terminated as provided in this Agreement, or unless the services to be performed or the Project is completed sooner. The term may be extended for three (3) additional one-year periods.
- 3. City shall pay to Supplier for the services described in the Agreement a total amount not to exceed Nine Hundred Thirty-Six Thousand One Hundred Twenty-Seven Dollars (\$936,127).
- 4. Except as expressly amended in this First Amendment, all terms and conditions in Agreement No. 35424 are ratified and confirmed and shall remain in full force and effect.
