

1 FIRST AMENDMENT TO AGREEMENT NO. 35845

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 35845 is made and
4 entered, in duplicate, as of April 19, 2021 for reference purposes only, pursuant to a minute
5 order adopted by the City Council of the City of Long Beach at its meeting on January 19,
6 2021, by and between INTERVAL HOUSE, a California nonprofit corporation
7 ("Organization"), with a place of business at 6615 E. Pacific Coast Highway, Suite 170,
8 Long Beach, California 90803-4221 and the CITY OF LONG BEACH, a municipal
9 corporation ("City").

10 WHEREAS, City requires specialized services requiring unique skills to be
11 performed in connection with providing rapid-rehousing and homelessness prevention
12 assistance to eligible residents of the City who are homeless or at risk homelessness; and

13 WHEREAS, City and Organization (the "Parties") entered into Agreement No.
14 35845 (the "Agreement") whereby Consultant agreed to provide these services; and

15 WHEREAS, the Parties desire to amend the term;

16 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
17 conditions herein contained, the Parties agree as follows:

18 1. Section 3 of the Agreement is hereby amended to read as follows.

19 "The term of this Agreement shall be the Operational Year beginning on
20 January 1, 2021 and ending on August 31, 2022, unless sooner terminated as provided
21 herein."

22 2. Except as expressly modified herein, all of the terms and conditions
23 contained in Agreement No. 35845 are ratified and confirmed and shall remain in full force
24 and effect.
