

1 for the fiscal year ending September 30, 2018; \$4,958,676 for the fiscal year
2 ending September 30, 2019; \$5,358,676 for the fiscal year ending September
3 30, 2020; and \$4,608,676 for fiscal year ending September 30, 2021. City's
4 liability for CVB's approved convention and tourism sales and development
5 programs shall not exceed those amounts. Those amounts include the sums
6 identified in Sections 17 and 18 hereof and are not additional thereto. The
7 amount for the fiscal year ending September 30, 2020 does not include the sum
8 identified in Section 18 of Agreement No. 28164 because the City will not
9 participate in the 2020 Tournament of Roses Parade. City reserves the right,
10 at any time during the term hereof, by notice from City's City Manager, to
11 redefine the scope of services within said amounts. By August 1 of each fiscal
12 year during the term hereof, City's City Manager shall notify CVB of the amount
13 of anticipated transient occupancy taxes to be appropriated by the City Council
14 from the City's Special Fund for convention and tourism sales and development
15 programs for the following fiscal year. No later than June 1 of each fiscal year
16 during the term hereof, CVB shall prepare and submit the marketing plan
17 referred to in Section 2(a) hereof based on the anticipated transient occupancy
18 taxes to be appropriated."

19 2. Except as expressly modified herein, all of the terms and conditions
20 contained in Agreement No. 28164 are ratified and confirmed and shall remain in full force
21 and effect.
