RE: Letter Agreement to Supplement Existing Agreement to Provide Services Relating to Bus Shelters

Dear Mr. Nion:

This letter will confirm our understanding concerning the terms of services to be provided to the City of Long Beach ("City") by Outfront Decaux Street Furniture, LLC ("Outfront/Decaux") associated with the Bus Shelter Replacement at Various Locations Project. This Letter Agreement will supplement the services already provided by Outfront/Decaux through the existing Agreement No. 34193 to Provide Services Relating to Bus Shelters.

## 1. Agreement

Outfront/Decaux agrees to provide all services as described in the existing Agreement 34193 for two newly installed City-owned ad-bearing shelters at the following locations:

- Northwest Corner of Willow Street and Magnolia Avenue
- Northeast Corner of Harding Street and Atlantic Avenue

The services that Outfront/Decaux shall provide include maintenance, repair, replacement, temporary or permanent removal, and reporting of maintenance activities. In addition, Outfront/Decaux shall provide advertising services per the existing Agreement 34193, including payment of an advertising fee to the City.

Upon termination or expiration of the existing Agreement 34193, the City shall maintain ownership of these two bus shelters. The City may request that Outfront/Decaux continue to provide services relating to bus shelters, provided the City has determined that it will extend the existing Agreement 34193. Additionally, the City may also decide to pursue alternative arrangements regarding maintenance and advertising operations for these two shelters upon termination or expiration of the existing Agreement 34193.

## 2. Term

This Letter Agreement shall be effective beginning on the date it is signed by both parties, and shall be co-terminus with existing Agreement 34193, unless otherwise determined by the City. In the event the City extends the existing Agreement 34193, this Letter Agreement shall also be extended, in writing, for a period determined by the City.
