

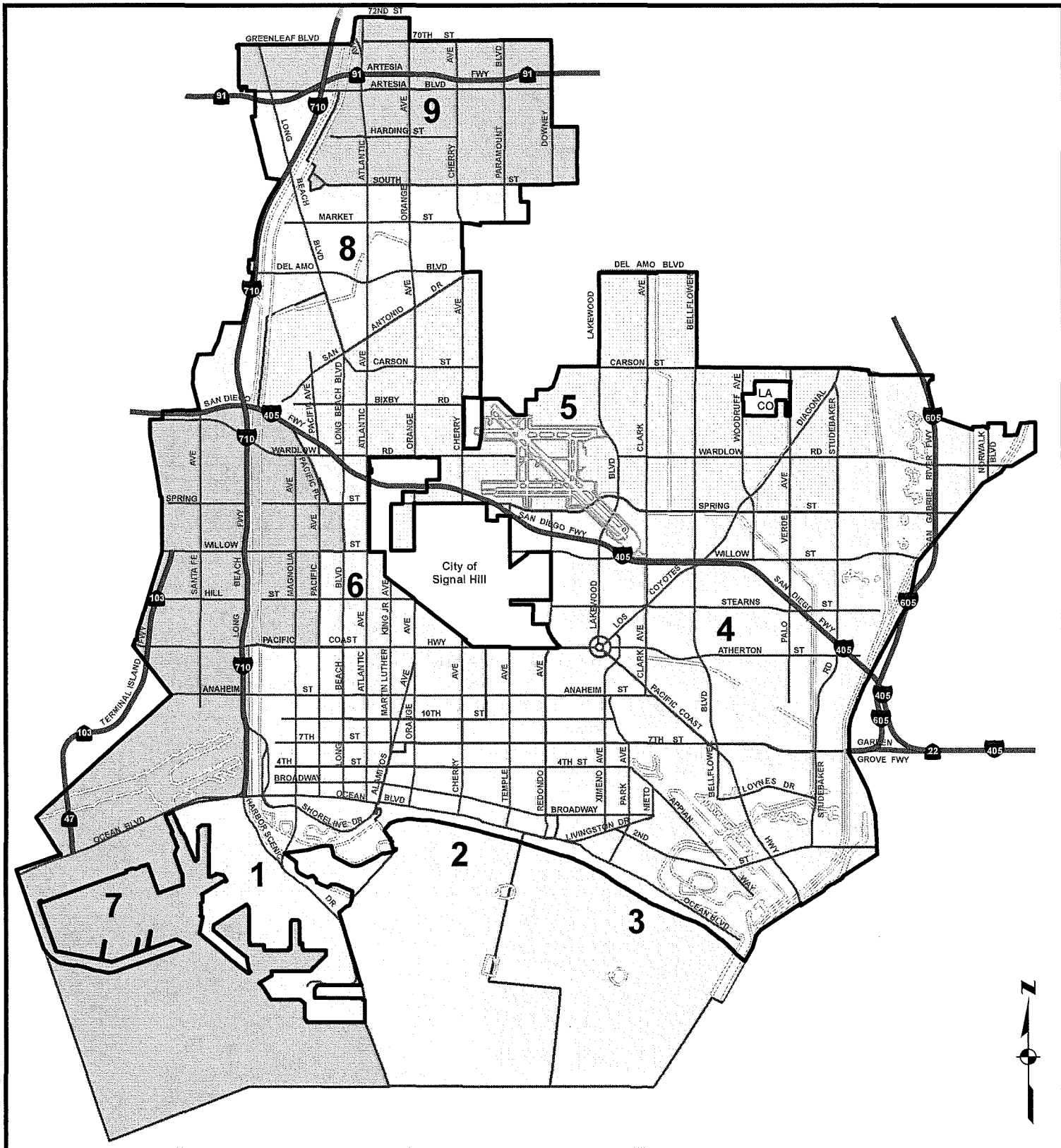

ORDINANCE NO.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AMENDING THE LONG BEACH MUNICIPAL CODE BY AMENDING SECTION 1.20.010 ESTABLISHING AND DESIGNATING THE POLITICAL SUBDIVISIONS OR DISTRICTS OF THE CITY OF LONG BEACH, PURSUANT TO THE ACTIONS OF THE LONG BEACH INDEPENDENT REDISTRICTING COMMISSION

WHEREAS, in 2018, the citizens of Long Beach adopted Measure DDD (Charter section 2500 et seq.) establishing the Independent Redistricting Commission (“Commission”) to re-draw City Council districts using decennial Census data as required by state and federal law; and

WHEREAS, after a lengthy and transparent process, on November 18, 2021, the Commission adopted a final map with new Council district boundaries; and

WHEREAS, the Commission further directed staff to take actions to rescind and replace the former Council district boundaries with the new boundaries; and

WHEREAS, consistent with Charter section 2500, an ordinance amending the Long Beach Municipal Code establishing the new boundaries is presented for adoption;

NOW, THEREFORE, the City Council of the City of Long Beach ordains as follows:

Section 1. Section 1.20.010 of the Long Beach Municipal Code is hereby amended to read as follows:

1.20.010 Districts established.

The nine (9) political subdivisions or districts of the City are

1 respectively designated and established as follows:

2 Unless otherwise noted, described lines are to the centerline of
3 referenced streets.

4 A. District No. 1. That portion of the City which is now, or
5 hereafter shall be, within the following described boundary:

6 Beginning at the intersection of the centerline of Ocean Boulevard with the
7 western pierhead line of Pier D; thence northeast and east along the centerline of Ocean
8 Boulevard to its intersection with the west line of the Los Angeles River; thence north
9 along the west line of the Los Angeles River to its intersection with the centerline of
10 Pacific Coast Highway; thence east along the centerline of Pacific Coast Highway to the
11 centerline of Long Beach Boulevard; thence south along the centerline of Long Beach
12 Boulevard to the centerline of East Tenth Street; thence east along the centerline of East
13 Tenth Street to the centerline of Cherry Avenue; thence south along the centerline of
14 Cherry Avenue to the centerline of Seventh Street; thence west along Seventh Street to
15 the centerline of Cerritos Avenue; thence south along the centerline of Cerritos Avenue to
16 the centerline of East Sixth Street; thence west along the centerline of East Sixth Street
17 to the centerline of Alamitos Avenue; thence southerly along the centerline of Alamitos
18 Avenue to the centerline of Ocean Boulevard; thence westerly along the centerline of
19 Ocean Boulevard to the centerline of Shoreline Drive; thence southerly along the
20 centerline of Shoreline Drive to Beach Access Road; thence easterly, northerly,
21 southerly, southwesterly and southeasterly to the southeast corner of Pier J; thence
22 westerly, northerly, easterly and southerly along the pierhead lines of Piers J, G, F, E, &
23 D to the intersection with the centerline of Ocean Boulevard and Point of Beginning.

24 B. District No. 2. That portion of the City which is now, or
25 hereafter shall be, within the following described boundary:

26 Beginning at the point of intersection of the centerline of Junipero Avenue
27 with the south boundary line of the City of Signal Hill; thence east along the south
28 boundary line of the City of Signal Hill to its intersection with the centerline of Redondo

1 Avenue; thence southerly along the centerline of Redondo Avenue to the centerline of
2 East Broadway; thence east along the centerline of East Broadway to the centerline of
3 Loma Avenue; thence southerly along the centerline of Loma Avenue to the centerline of
4 East Ocean Boulevard; thence westerly along the centerline of Ocean Boulevard to the
5 centerline of Paloma Avenue; thence southwesterly, southeasterly and southerly to the
6 south boundary line of the City of Long Beach; thence westerly along the south boundary
7 line of the City of Long Beach to a point; thence northwesterly to the southeast corner of
8 Pier J; thence northwesterly, northeasterly, northerly, southerly and westerly to Beach
9 Access Road southeasterly of the intersection of the centerline of Shoreline Drive with
10 the centerline of Ocean Boulevard; thence along Beach Access Road to the centerline of
11 Shoreline Drive; thence northerly along the centerline of Shoreline Drive to the centerline
12 of Ocean Boulevard; thence easterly along the centerline of Ocean Boulevard to the
13 centerline of Alamitos Avenue; thence northeasterly along the centerline of Alamitos
14 Avenue to the centerline of East Sixth Street; thence east along the centerline of East
15 Sixth Street to the centerline of Cerritos Avenue; thence north along the centerline of
16 Cerritos Avenue to the centerline of East Seventh Street; thence east along the centerline
17 of East Seventh Street to the centerline of Cherry Avenue; thence north along the
18 centerline of Cherry Avenue to the centerline of East Tenth Street; thence east along the
19 centerline of East Tenth Street to the centerline of Junipero Avenue; thence north along
20 the centerline of Junipero Avenue to its intersection with the south boundary line of the
21 City of Signal Hill and Point of Beginning.

22 C. District No. 3. That portion of the City which is now, or
23 hereafter shall be, within the following described boundary:

24 Beginning at the intersection of the centerline of Redondo Avenue with the
25 south boundary line of the City of Signal Hill; thence east and north along the south
26 boundary line of the City of Signal Hill to the east boundary line of the City of Signal Hill;
27 thence perpendicular to the centerline of Pacific Coast Highway; thence continuing east
28 along the centerline of Pacific Coast Highway to the centerline of Outer Traffic Circle;

1 thence southerly and easterly along the centerline of Outer Traffic Circle to the centerline
2 of Ximeno Way; thence northerly along the centerline of Ximeno Way to the centerline of
3 Pacific Coast Highway; thence southeasterly along the centerline of Pacific Coast
4 Highway to the centerline of East Seventh Street; thence easterly along the centerline of
5 East Seventh Street to its intersection with the east boundary line of the City of Long
6 Beach; thence southerly and southwesterly along the east boundary line of the City of
7 Long Beach to the southeasterly corner of the City of Long Beach; thence westerly along
8 the south boundary line of the City of Long Beach to a point, thence northerly, westerly
9 and northeasterly to the intersection of the centerline of East Ocean Boulevard with the
10 centerline of Paloma Avenue; thence easterly along the centerline of East Ocean
11 Boulevard to the centerline of Loma Avenue; thence northerly along the centerline of
12 Loma Avenue to the centerline of East Broadway; thence west along the centerline of
13 East Broadway to the centerline of Redondo Avenue; thence northerly along the
14 centerline of Redondo Avenue to the intersection with the south boundary line of the City
15 of Signal Hill and Point of Beginning.

16 D. District No. 4. That portion of the City which is now, or
17 hereafter shall be, within the following described boundary:

18 Beginning at the point of intersection of the east boundary line of the City of
19 Long Beach with the centerline of East Seventh Street; thence westerly along the
20 centerline of East Seventh Street to the centerline of Pacific Coast Highway; thence
21 northwesterly along the centerline of Pacific Coast Highway to the centerline of Ximeno
22 Way; thence southerly along the centerline of Ximeno Way to the centerline of Outer
23 Traffic Circle; thence westerly and northerly along the centerline of Outer Traffic Circle to
24 the centerline of Pacific Coast Highway; thence westerly along the centerline of Pacific
25 Coast Highway and north to the southeast corner of the City of Signal Hill boundary;
26 thence northwesterly, northerly and westerly along the east boundary line of the City of
27 Signal Hill and its northerly prolongation to its intersection with the centerline of Spring
28 Street; thence easterly along the centerline of Spring Street to the centerline of

1 Studebaker Road; thence north along the centerline of Studebaker Road to the centerline
2 of East Wardlow Road; thence east along the centerline of East Wardlow Road to the
3 east line of the San Gabriel River; thence northerly along the east line of the San Gabriel
4 River to its intersection with the north boundary line of the City of Long Beach; thence
5 easterly, southerly and northerly along the north boundary line of the City of Long Beach
6 to the east boundary of the City of Long Beach at Bloomfield Avenue; thence southerly
7 and southwesterly along said east boundary line of the City of Long Beach to its
8 intersection with the centerline of East Seventh Street and Point of Beginning.

9 E. District No. 5. That portion of the City which is now, or
10 hereafter shall be, within the following described boundary:

11 Beginning at the intersection of the centerline of Spring Street with the
12 northerly prolongation of the east boundary of the City of Signal Hill; thence south along
13 said prolongation of said City of Signal Hill boundary to the north boundary line of the City
14 of Signal Hill; thence west, east, south and north along the north boundary line of the City
15 of Signal Hill to the intersection of the west boundary line of the City of Signal Hill with the
16 405 Freeway; thence northwesterly along the 405 Freeway to the east line of the Los
17 Angeles River; thence northerly along the east line of the Los Angeles River to the Union
18 Pacific Railroad; thence northeasterly along the Union Pacific Rail Road to the centerline
19 of Long Beach Boulevard; thence southeasterly along the centerline of Long Beach
20 Boulevard to the centerline of East San Antonio Drive; thence northeasterly along the
21 centerline of East San Antonio Drive to the centerline of Cherry Avenue; thence north
22 along the centerline of Cherry Avenue to the City of Long Beach/City of Lakewood
23 boundary line at Del Amo Boulevard; thence easterly, westerly, southerly and northerly
24 along said common City of Long Beach/City of Lakewood boundary line to the east line of
25 the San Gabriel River; thence southerly along the east line of the San Gabriel River to the
26 centerline of Wardlow Road; thence west along the centerline of Wardlow Road to the
27 centerline of Studebaker Road; thence south along the centerline of Studebaker Road to
28 the centerline of East Spring Street; thence west along the centerline of East Spring

1 Street to its intersection with the northerly prolongation of the east boundary line of the
2 City of Signal Hill and Point of Beginning.

3 F. District No. 6. That portion of the City which is now, or
4 hereafter shall be, within the following described boundary:

5 Beginning at the intersection of the centerline of Pacific Coast Highway with
6 the centerline of Pacific Avenue; thence north along the centerline of Pacific Avenue to
7 the centerline of Willow Street; thence east along the centerline of Willow Street to the
8 centerline of Long Beach Boulevard; thence north along the centerline of Long Beach
9 Boulevard to the centerline of East Spring Street; thence west along the centerline of
10 East Spring Street to the Metro Blue Line Right-of-Way; thence northwesterly along the
11 Metro Blue Line Right-of-Way to the northerly prolongation of the centerline of Pacific
12 Avenue; thence southerly along the northerly prolongation of the centerline of Pacific
13 Avenue to the intersection with the centerline of Pacific Place; thence northwesterly along
14 the centerline of Pacific Place to the 405 Freeway; thence southeasterly along the 405
15 Freeway to the intersection with the west boundary line of the City of Signal Hill; thence
16 south, east and southeasterly along the west boundary line of the City of Signal Hill to the
17 south boundary of the City of Signal Hill at Pacific Coast Highway; thence east along the
18 south boundary line of the City of Signal Hill to the centerline of Junipero Avenue; thence
19 south along the centerline of Junipero Avenue to the centerline of East Tenth Street;
20 thence west along the centerline of East Tenth Street to the centerline of Long Beach
21 Boulevard; thence north along the centerline of Long Beach Boulevard to the centerline
22 of Pacific Coast Highway; thence west along the centerline of Pacific Coast Highway to
23 the centerline of Pacific Avenue and Point of Beginning.

24 G. District No. 7. That portion of the City which is now, or
25 hereafter shall be, within the following described boundary:

26 Beginning at an angle point on the west boundary line of the City of Long
27 Beach at Ocean Boulevard; thence northwesterly and northeasterly along said City of
28 Long Beach west boundary line to an angle point at the 405 Freeway; thence easterly

1 and southeasterly along the 405 Freeway to the intersection with the northerly
2 prolongation of the centerline of Pacific Place; thence southeasterly along said northerly
3 prolongation and the centerline of Pacific Place to the intersection with Pacific Avenue;
4 thence northerly along the northerly prolongation of the centerline of Pacific Avenue to
5 the intersection with the centerline of the Metro Blue Line Right-of-Way; thence southerly
6 along the centerline of the Metro Blue Line Right-of-Way to the centerline of East Spring
7 Street; thence east along the centerline of East Spring Street to the centerline of Long
8 Beach Boulevard; thence south along the centerline of Long Beach Boulevard to the
9 centerline of East Willow Street; thence west along the centerline of East Willow Street to
10 the centerline of Pacific Avenue; thence south along the centerline of Pacific Avenue to
11 the centerline of Pacific Coast Highway; thence west along the centerline of Pacific Coast
12 Highway to its intersection with the west line of the Los Angeles River; thence south
13 along the west line of the Los Angeles River to the intersection with the centerline of
14 Ocean Boulevard; thence west along the centerline of Ocean Boulevard to its intersection
15 with the west pierhead line of Pier D; thence southerly, easterly, northerly and westerly
16 along the pierhead lines of Piers D, E, F, G, & J to the southeasterly corner of Pier J;
17 thence southeasterly to the south boundary of the City of Long Beach; thence westerly
18 and southwesterly along the south boundary of the City of Long Beach to the most
19 southwesterly corner of the City boundary; thence northerly along the west City boundary
20 line to an angle point on said westerly line of the City of Long Beach at Ocean Boulevard
21 and Point of Beginning.

22 H. District No. 8. That portion of the City which is now, or
23 hereafter shall be, within the following described boundary:

24 Beginning at the intersection of the centerline of Long Beach Boulevard with
25 the centerline of East San Antonio Drive; thence northwesterly along the centerline of
26 Long Beach Boulevard to the Union Pacific Railroad; thence southwesterly along the
27 Union Pacific Railroad to the east line of the Los Angeles River; thence southerly along
28 the east line of the Los Angeles River to the 405 Freeway; thence westerly along the 405

1 Freeway to the west boundary line of the City of Long Beach; thence northerly, easterly,
2 and westerly along the west City boundary line to its intersection with the centerline of
3 Artesia Boulevard; thence easterly along the centerline of Artesia Boulevard to the
4 centerline of the Los Angeles River; thence southerly along the centerline of the Los
5 Angeles River to its intersection with the westerly prolongation of the centerline of East
6 Fifty-Ninth Street; thence southeasterly along the said westerly prolongation of the
7 centerline of East Fifty-Ninth Street to the centerline of De Forest Avenue; thence
8 southerly along the centerline of De Forest Avenue to the centerline of Chestnut Avenue;
9 thence southerly along the centerline of Chestnut Avenue to the centerline of North
10 Jaymills Avenue; thence northeasterly along the centerline of North Jaymills Avenue to
11 the centerline of South Street; thence easterly along the centerline of South Street to the
12 common boundary line of the City of Long Beach/City of Lakewood; thence south, east
13 and west along said common boundary of the City of Long Beach/City of Lakewood and
14 continuing south, to the centerline intersection of Cherry Avenue and East San Antonio
15 Drive; thence southwesterly along the centerline of San Antonio Drive to the centerline of
16 Long Beach Boulevard and Point of Beginning.

17 I. District No. 9. That portion of the City which is now, or
18 hereafter shall be, within the following described boundary:

19 Beginning at the intersection of the centerline of Long Beach Boulevard with
20 the centerline of East San Antonio Drive; thence northwesterly along the centerline of
21 Long Beach Boulevard to the Union Pacific Railroad; thence southwesterly along the
22 Union Pacific Railroad to the east line of the Los Angeles River; thence southerly along
23 the east line of the Los Angeles River to the 405 Freeway; thence westerly along the 405
24 Freeway to the west boundary line of the City of Long Beach; thence northerly, easterly,
25 and westerly along the west City boundary line to its intersection with the centerline of
26 Artesia Boulevard; thence easterly along the centerline of Artesia Boulevard to the
27 centerline of the Los Angeles River; thence southerly along the centerline of the Los
28 Angeles River to its intersection with the westerly prolongation of the centerline of East

1 Fifty-Ninth Street; thence southeasterly along the said westerly prolongation of the
2 centerline of East Fifty-Ninth Street to the centerline of De Forest Avenue; thence
3 southerly along the centerline of De Forest Avenue to the centerline of Chestnut Avenue;
4 thence southerly along the centerline of Chestnut Avenue to the centerline of North
5 Jaymills Avenue; thence northeasterly along the centerline of North Jaymills Avenue to
6 the centerline of South Street; thence easterly along the centerline of South Street to the
7 common boundary line of the City of Long Beach/City of Lakewood; thence south, east
8 and west along said common boundary of the City of Long Beach/City of Lakewood and
9 continuing south, to the centerline intersection of Cherry Avenue and East San Antonio
10 Drive; thence southwesterly along the centerline of San Antonio Drive to the centerline of
11 Long Beach Boulevard and Point of Beginning.

13 Section 2. The City Clerk shall certify to the passage of this ordinance by
14 the City Council and cause it to be posted in three (3) conspicuous places in the City of
15 Long Beach, and it shall take effect on the thirty-first (31st) day after it is approved by the
16 Mayor.
