FIRST AMENDMENT TO AGREEMENT NO. 34815

34815

THIS FIRST AMENDMENT TO AGREEMENT NO. 34815 is made and entered, in duplicate, as of September 9, 2019, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on July 18, 2017, by and between DIGITAL EMS SOLUTIONS INC., a California corporation ("Contractor"), with a place of business at 34 Savona Walk, Long Beach, California 90803, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 34815 (the "Agreement") whereby Contractor agreed to provide services in connection with a new Electronic Patient Care Report System for the Long Beach Fire Department; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 2 of the Agreement is hereby amended to read as follows:

"2. TERM. The term of this Agreement shall commence at midnight on November 1, 2017, and shall terminate at 11:59 p.m. on October 31, 2020, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The Parties have the option to extend the term one (1) additional one-year period, at the discretion of the City Manager."

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 34815 are ratified and confirmed and shall remain in full force and effect.


