

RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH IN SUPPORT OF SENATE BILL 1050 (BOWEN) REQUIRING A QUALIFIED WRITE-IN VOTE TO BE COUNTED REGARDLESS OF THE PRESENCE OF AN ADDITIONAL MARK IN THE SPACE PROVIDED

WHEREAS, fundamental provisions of the Long Beach City Charter acknowledge and reflect the City's long-standing tradition of write-in candidacies; and

WHEREAS, the tradition was well demonstrated by the historic write-in candidacy of its own Honorable Mayor Beverly O'Neill in June 2002; and

WHEREAS, neither federal nor state funding is provided to educate voters on how to vote or improve municipal poll worker training efforts; and

WHEREAS, the California Voter Foundation has reported that 42% of all infrequent voters feel that voting is too confusing and complicated; and

WHEREAS, first-time voters, including young and old residents, may be overwhelmed in having to comprehend multi-jurisdictional ballot contests and measures for the very first time; and

WHEREAS, City and other municipal and special district elections are known for their close races in which a single vote can make the difference; and

WHEREAS, the City of Long Beach would like to promote and uphold the principle that every vote shall be counted; and

WHEREAS, the 2004 City of San Diego General Election had Donna Frye, a qualified write-in candidate, lose by about 2,000 votes due to the 5,000 votes that were not counted under law (Election Code 15432);

Sec. 3. This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify the vote adopting this resolution.
