3 THIS FIRST AMENDMENT TO RIGHT OF ENTRY PERMIT NO. P-00180 is
4 made and entered, in duplicate, as of July 12, 2022, for reference purposes only,
5 pursuant to authorization by the PARKS AND RECREATION COMMISSION of the City of
6 Long Beach ("Commission") at its meeting on March 22, 2018, by and between
7 HONORING OUR FALLEN HEROES, a 501(C)(3) California nonprofit corporation
8 ("Permittee"), whose address is 12111 Saint Mark Street, Garden Grove, California
9 92845, and the CITY OF LONG BEACH, a municipal corporation ("City").

10 WHEREAS, City and Permittee (the "Parties") entered into Right of Entry
11 Permit No. P-00180 (the "Permit") whereby City granted Permittee, its contractors,
12 agents, and employees the non-exclusive right to enter City-owned property solely for the
13 purpose and to the extent reasonably necessary for the addition of more name plaques to
14 the existing Memorial Wall and ongoing maintenance of existing signage at Rosie the
15 Riveter Park; and

16 WHEREAS, the Parties desire to extend the term of the Permit for an
17 additional three (3) year term;

18 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
19 conditions herein contained, the Parties agree as follows:

20 1. Section 3.1 of the Permit is hereby amended to read as follows:

21 "3.1. Permission to enter shall begin on April 1, 2018 and, unless
22 extended in writing, shall end on March 31, 2024, unless sooner
23 terminated as provided in this Permit, or the services to be performed
24 hereunder or the project is completed sooner."

25 2. Except as expressly modified herein, all of the terms and conditions
26 contained in the Permit are ratified and confirmed and shall remain in full force and effect.

27 3. Permittee consents to and agrees to perform the terms, covenants,
28 and conditions imposed on Permittee under the Permit during the renewal period.
