A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH ENTERPRISE FLEET MANAGEMENT, INC., WITHOUT ADVERTISING FOR BIDS, FOR THE PURCHASE OF FOURTEEN (14) USED VEHICLES, IN A TOTAL AMOUNT NOT TO EXCEED \$205,000

WHEREAS, the Police Department leased a total of fourteen (14) vehicles from Enterprise Fleet Management, Inc., in 2011 and 2014; and

WHEREAS, the Police Department currently uses said vehicles for undercover and surveillance operations; and

WHEREAS, eight (8) of the fourteen (14) vehicles have completed their lease term and are in a monthly rental status; and

WHEREAS, the remaining six vehicles are leased until 2018; and

WHEREAS, there is a continuing need for these vehicles and therefore it would be more cost-effective to purchase the vehicles rather than to continue renting and leasing; and

WHEREAS, no useful purpose would be served by advertising for bids and to do so would constitute an idle and useless act and an unnecessary expenditure of public funds;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. The above recitals are true and correct and are incorporated herein.

Section 2. The City Manager is hereby authorized to enter a contract
