THIS FIRST AMENDMENT TO AGREEMENT NO. 32444 is made and entered, in duplicate, as of November 7, 2013 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on December 20, 2011 and a minute order adopted by the Board of Trustees of the Long Beach Community College District at its meeting held on October 25, 2011, by and LONG BEACH COMMUNITY COLLEGE DISTRICT, a public corporation whose address is 4901 E. Carson Street, Long Beach, California 90808 ("District"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City collects parking citation fines and forfeitures through the use of an automated parking system; and

WHEREAS, District has a parking enforcement program on its campuses and has requested the City to process District's parking citations; and

WHEREAS, the parties entered Agreement No. 32444 whereby City agreed to provide such services; and

WHEREAS, the parties desire to extend the term of the Agreement;

NOW, THEREFORE, in consideration of the mutual terms and conditions in the Agreement and in this First Amendment, the parties agree as follows:

1. Section 3.A of Agreement No. 32444 is hereby amended to read as follows:

3. TERM AND TERMINATION.

A. The term of this Agreement shall commence at midnight on December 27, 2011, and shall terminate at 11:59 p.m. on December 26, 2014, unless sooner terminated as provided in this Agreement. The parties have the option to extend the term for two (2) additional one (1) year terms."

2. Except as expressly amended in this First Amendment, all terms and conditions in Agreement No. 32444 are ratified and confirmed and shall remain in full

1 force and effect.
