WHEREAS, the parties entered Agreement No. 23214 whereby Tiburon agreed to provide specialized data processing services relating to computer-aided dispatching and records management systems for City's Police and Fire Departments ("Project") and to grant a license and maintenance for the Project; and

WHEREAS, the Agreement has previously been amended to extend the term and to add services; and

WHEREAS, the parties desire again to amend the Agreement to extend the term and to pay for services received during the extended term;

NOW, THEREFORE, in consideration of the mutual terms and conditions in Agreement No. 23214 and herein, the parties agree as follows:

- 1. The term for support and maintenance of the computer-aided dispatch software ("CAD") is hereby extended beginning on November 1, 2004 and ending on February 28, 2005.
- 2. Notwithstanding anything to the contrary in the Agreement or in any attachment or exhibit to the Agreement, Tiburon shall perform the support and maintenance services with respect to CAD that are described in the Agreement, including previous Amendments, exhibits and attachments, and City shall pay the fees for those services, as more particularly identified in Exhibit "A" attached to this Eleventh Amendment and incorporated by this reference, during the extended term described in Section 1 above.


