WHEREAS, the Parties entered into a First Amendment to the Agreement to add \$13,350 for a total not to exceed amount of \$223,350, and extend the term to November 30, 2022; and

WHEREAS, the Parties desire to extend the term to September 30, 2023;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 2 of the Agreement is hereby amended to read as follows:
- 2. <u>TERM.</u> The term of this Agreement shall commence at midnight on May 5, 2021, and shall terminate at 11:59 p.m. on September 30, 2023, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner.
- Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 36306 are ratified and confirmed and shall remain in full force and effect.
