

1 FIRST AMENDMENT TO AGREEMENT NO. 29452

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 29452 is made and
4 entered, in duplicate, as of September 22, 2008 for reference purposes only, pursuant to
5 a minute order adopted by the City Council of the City of Long Beach at its meeting on
6 December 13, 2005, by and between FRED DARLAND, an individual, with a place of
7 business at 44850 Raven Lane, Mendocino, CA 95460 ("Consultant"), and the CITY OF
8 LONG BEACH, a municipal corporation ("City").

9 WHEREAS, the parties entered Agreement No. 29452 and Consultant
10 agreed to provide specialized services requiring unique skills to be performed in
11 connection with maintenance of software and web hosting; and

12 WHEREAS, the parties desire to extend the term of the Agreement;

13 NOW, THEREFORE, in consideration of the mutual terms and conditions in
14 the Agreement and in this Amendment, the parties agree as follows:

15 1. Section 2 of Agreement No. 29452 is amended in its entirety to read
16 as follows:

17 "2. TERM. The initial term of this Agreement shall commence at
18 midnight on October 1, 2005 and shall terminate at 11:59 p.m. on September 30, 2008.
19 The first extended term of this Agreement shall commence at midnight on October 1,
20 2008 and shall terminate at 11:59 p.m. on September 30, 2009, unless sooner terminated
21 as provided in this Agreement, or unless the services to be performed or the Project is
22 completed sooner."

23 2. Except as expressly amended in this First Amendment, all terms and
24 conditions in Agreement No. 29452 are ratified and confirmed and shall remain in full
25 force and effect.




