3 THIS FIRST AMENDMENT TO AGREEMENT is made and entered, in
4 duplicate, as of August 18, 2020 for reference purposes only, pursuant to a minute order
5 adopted by the City Council of the City of Long Beach at its meeting on TWO SIS THREE
6 BROS LLC DBA BAHN THAI RESTAURANT, a California limited liability company
7 ("Contractor"), with a place of business at 5802 Downey Ave., Long Beach, CA 90805, and
8 the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City and Contractor (the "Parties") entered into Agreement
10 ("Agreement") whereby Contractor agreed to provide the specialized services as described
11 in Request for Proposals Number CM20-058; and

12 WHEREAS, the Parties desire to extend the term of the Agreement;

13 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
14 conditions herein contained, the Parties agree as follows:

15 1. Section 2. of Agreement is hereby amended to read as follows:

16 "2. TERM. The term of this Agreement shall commence at midnight on
17 June 22, 2020, and shall terminate at 11:59 p.m. on August 22, 2020, with the option to
18 renew for two (2) additional one month periods based on program extensions from the
19 state, at the discretion of the City Manager."

20 2. Except as expressly modified herein, all of the terms and conditions
21 contained in this Agreement are ratified and confirmed and shall remain in full force and
22 effect.
