3 A RESOLUTION OF THE CITY COUNCIL OF THE  
4 CITY OF LONG BEACH AUTHORIZING THE CITY  
5 MANAGER TO EXECUTE, ON BEHALF OF THE CITY, A  
6 CONTRACT WITH ASBURY ENVIRONMENTAL SERVICES  
7 WITHOUT ADVERTISING FOR BIDS FOR FURNISHING,  
8 INSTALLING AND MONITORING CATCH BASIN INSERTS  
9

10 WHEREAS, the State Budget Act for Fiscal Year 2000-2001 resulted in a  
11 grant of three million, five hundred thousand dollars (\$3,500,000.00) to the City for various  
12 stormwater projects, and

13 WHEREAS, urban runoff is a significant source of bacteria and pathogens  
14 in the receiving waters of the City, and

15 WHEREAS, the Department of Public Works proposes to use one million  
16 dollars (\$1,000,000.00) of the above-described State funding to purchase and install catch  
17 basin inserts which include special "Smart Sponge" and "Ultra-Urban" technology to  
18 capture bacteria and pathogens, as well as trash, sediment, and hydrocarbons, and to  
19 monitor these installations for one year, and

20 WHEREAS, Asbury Environmental Services is the exclusive distributor in  
21 California for this technology, and

22 WHEREAS, as a result, no useful purpose would be served by advertising  
23 for bids to furnish, install and monitor catch basin inserts with this technology;

24 NOW, THEREFORE, the City Council of the City of Long Beach resolves as  
25 follows:

26 Section 1. That the above recitals are true and correct and are incorporated  
27 herein by this reference.

28 Sec. 2. The City Manager is hereby authorized to execute all documents

2 amount not to exceed one million dollars (\$1,000,000.00)

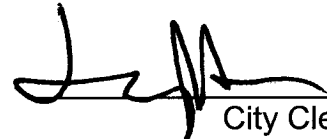
3 Sec. 2. This resolution shall take effect immediately upon its adoption by the
